The Ohio Department of Transportation (ODOT) will be holding two (2) public meetings for the I-75 Mill Creek Expressway Study. The purpose of these public meetings will be to show the alternatives currently under consideration for improvements to Interstate 75 between the Western Hills Viaduct and the Paddock Road Interchange.
