PUBLIC MEETING SCHEDULED

The Ohio Department of Transportation (ODOT), District 8, has scheduled a public meeting for the I-75 Mill Creek Expressway Study. The meeting will be held **Thursday, September 28, 2006** at the St. Bernard Municipal Building at 120 Washington Avenue, St. Bernard, OH 45217. The meeting will be held from **4pm to 8pm** and will be an "open house" style. The public may visit at any time during the meeting to view the exhibits and ask questions. No formal presentations will be made.

The purpose of this public meeting will be to show the alternatives currently under consideration for improvements to Interstate 75 between the Western Hills Viaduct and the Paddock Road interchange, plus the section of I-74 from I-75 to the Colerain/Beekman interchange. The primary goal of the I-75 Mill Creek Expressway Study is to evaluate alternatives to reduce congestion, improve safety, and correct substandard roadway conditions that contribute to these problems. Some potential improvements include additional lanes on I-75 and interchange upgrades.

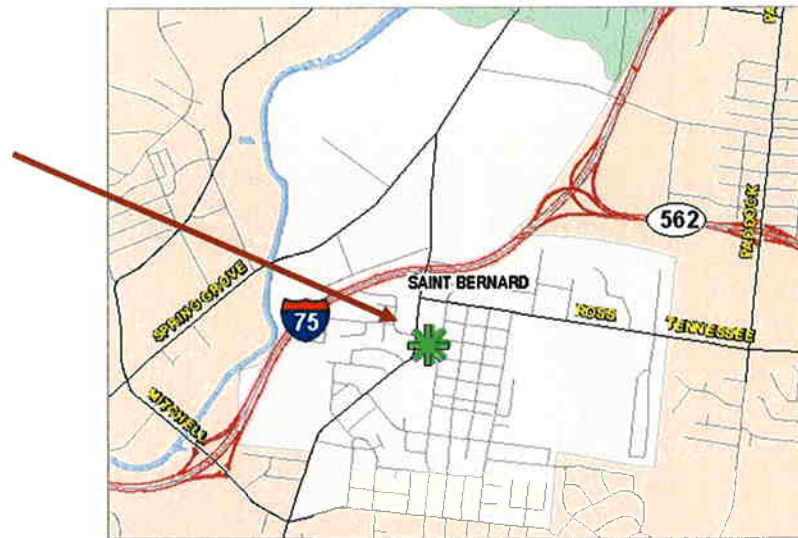
Comments on the alternatives will be accepted until October 12, 2006. Comments may be submitted at the meeting or mailed to Hans Jindal at the following location:
